

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0251

Affirmed

Ineligible for Pandemic Unemployment Assistance Weeks 16-20 through 35-21

PROCEDURAL HISTORY: On May 20, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not eligible for PUA benefits effective April 12, 2020 because claimant failed to provide acceptable proof of employment or self-employment within the required period. On June 8, 2021, claimant filed a timely request for hearing on the May 20, 2021 PUA Determination. On July 15, 2021, the Department served an amended Notice of Determination for PUA concluding that claimant was not eligible for PUA benefits effective April 12, 2020 and allowing claimant to submit additional proof of employment or self-employment by September 4, 2021. Claimant's June 8, 2021 request for hearing was treated as a request for hearing on the July 15, 2021 PUA Determination. On January 27, 2023, ALJ Lucas conducted a hearing, and on February 2, 2023 issued Order No. 23-UI-214581, affirming the July 15, 2021 amended Notice of Determination for Pandemic Unemployment Assistance by concluding that claimant was ineligible for PUA effective April 12, 2020¹. On February 22, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-214581 is affirmed.

¹ Order No. 23-UI-214581 concluded that claimant was ineligible for PUA during the entire period at issue, which began April 12, 2020. Order No. 23-UI-214581 at 1-2. However, the order then misstated the effective date of ineligibility as June 21, 2020 rather than April 12, 2020, which is likely a scrivener's error. Order No. 23-UI-214581 at 4.
