EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0252

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 1, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective January 26, 2020 (decision # 102822). Claimant filed a timely request for hearing. On January 20, 2023, ALJ Logan conducted a hearing, and on January 26, 2023 issued Order No. 23-UI-213874, reversing decision # 102822 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On February 15, 2023, Order No. 23-UI-213874 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On February 22, 2023, the employer filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the employer's written statements with their late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-213874, mailed to the employer on January 26, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-213874 at 3. Order No. 23-UI-213874 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 15, 2023 to be timely."

CONCLUSION AND REASONS: The employer's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-213874 was due February 15, 2023. Because the employer did not file their application for review until February 22, 2023, the application for review was late. The employer provided written statements with their application for review. However, the employer's statements largely focused on the reasons why they disagreed with the conclusions of the order under review. The employer mentioned in their February 22, 2023 emailed statement that the filing system "continually rejects" their application for review. EAB Exhibit 1 at 1. However, the employer did not assert that they made any attempts to file an application for review by the Wednesday, February 15, 2023 deadline, or explain why they waited until Wednesday, February 22, 2023 to inform EAB of any difficulties in filing. Thus, the employer has failed to assert that they faced circumstances that prevented them from timely filing their application for review. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The late application for review filed February 22, 2023 is dismissed. Order No. 23-UI-213874 remains undisturbed.
