EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0255

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On May 6, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective February 13, 2022 (decision # 115452). On May 26, 2022, decision # 115452 became final without claimant having filed a request for hearing. On May 27, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 7, 2022 issued Order No. 22-UI-202188, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 21, 2022. On September 27, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-202188 with the Employment Appeals Board (EAB). On February 22, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's September 27, 2022 application for review of Order No. 22-UI-202188.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 22-UI-202188 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 115452 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

On May 6, 2022, the Department mailed decision # 115452 to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was May 26, 2022. Claimant did not file a request for hearing until May 27, 2022. Accordingly, claimant's request for hearing was late.

Claimant filed their request for hearing on decision # 115452 via an online form submitted electronically on May 27, 2022 at 12:22 a.m. Exhibit 2 at 2. In their appellant questionnaire response, claimant indicated that they filed their request for hearing late because they were "struggling with major depression disorder and [felt] like there was honestly no point in filing so I was going to give up[.]" EAB Exhibit 1 at 1. If symptoms from a mental health condition were of such a debilitating nature that claimant was unable to request a hearing, claimant's late request for hearing may have been due to factors beyond their reasonable control. However, further inquiry is needed to determine whether claimant had good cause to file the late request for hearing, and whether they filed the late request for hearing within a reasonable time. On remand, the ALJ should develop the record regarding the nature and extent of claimant's major depression disorder. The ALJ should ask questions to assess the severity of claimant's symptoms. The ALJ should inquire whether it was possible for claimant to request a hearing in a timely manner while experiencing the symptoms and, if not, how their circumstances changed such that they were able to request a hearing on May 27, 2022. The ALJ should also ask any other questions necessary to determine whether claimant had good cause to file the late request for hearing, and whether they filed the late request for hearing within a reasonable time.

Order No. 22-UI-202188 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 115452.

DECISION: Order No. 22-UI-202188 is set aside, and this matter remanded for further proceedings consistent with this order.
