EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0268

Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits from January 16 through 29, 2022 (weeks 03-22 through 04-22), and until the reason for the denial had ended (decision # 113335). Also on February 17, 2022, the Department served notice of an administrative decision concluding that claimant was not available for work from January 16 through 29, 2022 (weeks 03-22 through 04-22) and was not eligible for benefits for those weeks and until the reason for the denial had ended (decision # 70556). On March 9, 2022, decisions # 113335 and 70556 became final without claimant having filed a request for hearing. On August 6, 2022, claimant filed late requests for hearing on decisions # 113335 and 70556. ALJ Kangas considered claimant's requests, and on August 30, 2022 issued Orders No. 22-UI-201650 and 22-UI-201648, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by September 13, 2022. Claimant did not respond to the appellant questionnaire. On September 19, 2022, claimant filed timely applications for review of Orders No. 22-UI-201650 and No. 22-UI-201648 with the Employment Appeals Board (EAB). ¹

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-201650 and No. 22-UI-201648. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0267 and 2023-EAB-0268).

CONCLUSIONS AND REASONS: Claimant's late requests for hearing are dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The requests for hearing on decision # 113335 and 70556 were due by March 9, 2022. Because claimant did not file their requests for hearing until August 6, 2022, the requests were late.

The record on review fails to show why claimant filed their requests for hearing late. Claimant filed applications for review of the underlying hearing orders, but did not submit an appellant questionnaire response. Nor do the exhibits in these cases, which consist of decisions # 113335 and 70556 and claimant's electronic hearing request forms, shed light on why claimant did not appeal by the March 9, 2022 deadline. Therefore, it is not evident that claimant's late requests for hearing were late because of factors beyond claimant's reasonable control or an excusable mistake. Nor has claimant shown that they filed their hearing requests within a seven-day reasonable time period of when any such factors ceased to exist.

For these reasons, claimant failed to establish good cause to extend the filing deadlines for decisions # 113335 and 70556 beyond March 9, 2022. Accordingly, claimant's late requests for hearing are dismissed.

DECISION: Orders No. 22-UI-201650 and 22-UI-201648 are affirmed.
