

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0280

Affirmed
Ineligible Weeks 22-21 through 31-21

PROCEDURAL HISTORY: On June 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during each of the weeks including May 30, 2021 through June 12, 2021 (weeks 22-21 through 23-21) and was not eligible to receive unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 95048). Claimant filed a timely request for hearing. On February 16, 2023, ALJ D. Lee conducted a hearing, and on March 2, 2023 issued amended Order No. 23-UI-217684¹, modifying decision # 95048 by concluding that claimant was not able, available, nor actively seeking work during each of the weeks including May 30, 2021 through August 7, 2021 (weeks 22-21 through 31-21). On March 3, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-217684 is affirmed.
