

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0287

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On March 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work for the weeks including February 20, 2022 through March 12, 2022 (weeks 8-22 through 10-22), and was therefore not eligible to receive benefits for that period and until the reason for the denial had ended (decision # 100652). Claimant filed a timely request for hearing. On May 16, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 26, 2022. On May 26, 2022, claimant failed to appear at the hearing, and on May 27, 2022, ALJ Micheletti issued Order No. 22-UI-194896 dismissing claimant's request for hearing for failure to appear. On June 16, 2022, Order No. 22-UI-194896 became final without claimant having filed a request to reopen the May 26, 2022 hearing. On February 9, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request and on February 22, 2023, issued Order No. 23-UI-216792, denying the request and leaving Order No. 22-UI-194896 undisturbed. On March 6, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-216792 is affirmed.
