EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0299

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 26, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits from December 6, 2020 through September 4, 2021 (weeks 50-20 through 35-21). Claimant filed a timely request for hearing. On April 20, 2022, The Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 3, 2022. On May 3, 2022, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 22-UI-192828, dismissing claimant's request for hearing due to his failure to appear. On May 9, 2022, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on October 17, 2022 issued Order No. 22-UI-205245, denying the request and leaving Order No. 22-UI-192828 undisturbed. On November 4, 2022, claimant filed an application for review of Order No. 22-UI-205245 with the Employment Appeals Board (EAB).

On December 30, 2022, EAB issued EAB Decision 2022-EAB-1107, reversing Order No. 22-UI-205245 by allowing claimant's request to reopen the May 3, 2022 hearing and remanding the matter for a hearing on the merits of the January 26, 2022 PUA determination. On February 9, 2023, ALJ Frank conducted a hearing, and on February 14, 2023 issued Order No. 23-UI-215977, affirming the January 26, 2022 PUA determination. On March 6, 2023, Order No. 23-UI-215977 became final without claimant having filed an application for review with EAB. On March 9, 2023, claimant filed a late application for review of Order No. 23-UI-215977 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the written statement with attachments claimant provided with his late application for review and has been marked as EAB Exhibit 2, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: Order No. 23-UI-215977, mailed to claimant on February 14, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-215977 at 3. Order No. 23-UI-215977 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 6, 2023 to be timely."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-215977 was due March 6, 2023. Because claimant did not file their application for review until March 9, 2023, the application for review was late. Claimant's application for review included a written statement, but the statement only described why claimant disagreed with Order No. 23-UI-215977, and not any circumstances that prevented claimant from filing the application for review by the March 6, 2023 deadline. EAB Exhibit 2 at 1-4. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed March 9, 2023 is dismissed. Order No. 23-UI-215977 remains undisturbed.
