# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0300

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 10, 2021 the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective May 2, 2021 (decision # 134733). Claimant filed a timely request for hearing. On June 24, 2022, ALJ Demarest conducted a hearing, and on June 29, 2022, issued Order No. 22-UI-197113, affirming decision # 134733. On July 19, 2022, Order No. 22-UI-197113 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 9, 2023, claimant filed a late application for review with EAB.

WRITTEN ARGUMENT: Claimant's written argument contained copies of medical records but did not contain information about why claimant filed the application for review after the July 19, 2022 deadline. If claimant's medical conditions prevented her from timely filing the application for review, this could potentially constitute good cause for filing a late application for review. As discussed below, claimant may wish to request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019), and at that time explain why she filed her application for review after July 19, 2022, including whether and if so, how, her medical conditions prevented her from timely filing the application for review. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information in the record when reaching this decision.

**CONCLUSIONS AND REASONS:** The application for review is dismissed without prejudice.

On March 9, 2023, the appellant filed an application for review of Order No. 22-UI-197113 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than July 19, 2022. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). Good cause could potentially include a failure to receive the administrative decision because of a loss of housing or mental and physical health conditions that prevented appellant from being able to timely file. If the appellant

believes they have good cause, and that they filed their late application for review within a reasonable time after this good cause ceased to exist, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is April 12, 2023, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review on March 9, 2023 after the July 19, 2022 deadline. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before July 19, 2022, how the reason(s) affected their ability to file a timely application for review. Such reasons may include:

whether mental or physical health issues prevented them from being able to timely file, whether a loss of housing or an unexpected move caused them to not receive the order timely,

and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and* 

- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) stopped, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or

**DECISION:** The application for review filed March 9, 2023 is dismissed without prejudice. Order No. 22-UI-197113 remains undisturbed.
