

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0303**

*Reversed & Remanded*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On May 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work and was therefore disqualified from receiving unemployment insurance benefits effective April 17, 2022 (decision # 62616). On June 7, 2022, decision # 62616 became final without claimant having filed a request for hearing. On June 28, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 5, 2022 issued Order No. 22-UI-204308, dismissing the request as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 19, 2022. On October 24, 2022, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH) and a timely application for review by the Employment Appeals Board (EAB). On March 13, 2023, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, OAH would not consider it or issue another order, and that Order No. 22-UI-204308 remained in effect. This matter comes before EAB based upon claimant's October 24, 2022 application for review of Order No. 22-UI-204308.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** Order No. 22-UI-204308 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 62616 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on decision # 62616 was June 7, 2022. Claimant filed a request for hearing on June 28, 2022. Therefore, claimant’s request for hearing was late. In claimant’s response to the appellant questionnaire, they wrote that the reason for the late filing was because they were “sick.” EAB Exhibit 1 at 2. If claimant was prevented by illness from timely filing their request for hearing, this may have constituted a factor beyond claimant’s reasonable control. Further development of the record is needed to determine the extent of claimant’s illness, whether the illness prevented them from timely filing their request for hearing, and whether claimant filed their late request for hearing within a reasonable time after the factors beyond claimant’s reasonable control ceased to exist.

Because further development of the record is necessary for a determination of whether claimant had good cause to file a late request for hearing, Order No. 22-UI-204308 is reversed, and this matter remanded for a hearing on whether the late request for hearing on decision # 62616 should be allowed and, if so, the merits of that decision.

**DECISION:** Order No. 22-UI-204308 is set aside, and this matter remanded for further proceedings consistent with this order.
