## EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0304

Affirmed
Late Request for Hearing Allowed
Ineligible Week 33-21
Eligible Week 19-22

**PROCEDURAL HISTORY:** On September 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was unable to work from August 15 through 21, 2021 (week 33-21) and therefore was ineligible for benefits for that week and until the reason for the denial had ended (decision # 85710). On September 29, 2021, decision # 85710 became final without claimant having filed a request for hearing. On October 6, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 6, 2021 issued Order No. 21-UI-181212, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 20, 2021. On December 13, 2021, claimant filed a timely response to the appellant questionnaire. On March 28, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-181212 was vacated and that a new hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 85710.

On February 9, 2023, ALJ L. Lee conducted a hearing, and on February 21, 2023 issued Order No. 23-UI-216626, allowing claimant's late request for hearing and modifying decision # 85710 by concluding that claimant was not able to work during week 33-21 and therefore was ineligible for benefits for that week, but was able to work from May 8 through 14, 2022 (week 19-22) and therefore was eligible for benefits for that week. On March 13, 2023, claimant filed an application for review of Order No. 23-UI-216626 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-216626 is affirmed.
