EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0324

Affirmed
Overpayment Waiver Granted

PROCEDURAL HISTORY: On December 16, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's requests for waivers of overpayments of Pandemic Unemployment Assistance (PUA) and Federal Pandemic Unemployment Compensation (FPUC) benefits (decision # 141824). Claimant filed a timely request for hearing. On March 8, 2023, ALJ Scott conducted a hearing, and on March 9, 2023 issued Order No. 23-UI-218595, reversing decision # 141824 by granting claimant's request for waiver of the PUA and FPUC overpayments. On March 20, 2023, the Department filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the Department's written argument when reaching this decision.

In its written argument, the Department asserted that claimant should not be eligible for a waiver because the overpayment of PUA and FPUC benefits were claimant's fault, as he was not eligible for PUA benefits. Department's Written Argument at 1. This assertion is not supported by the record. Rather, the record shows that the underlying overpayment was determined, as a matter of law, not to have been the result of claimant's having made a material representation to obtain benefits.

Further, federal guidance provides that, in general, "an individual is considered to be without fault when the individual provided all information correctly as requested by the state, but the state failed to take appropriate action with that information or took delayed action when determining eligibility." Unemployment Insurance Program Letter 20-21, Change 1 (UIPL 20-21 Change 1) at 9 (February 7, 2022). However, "a state may also find that an individual is without fault if the individual provided incorrect information due to conflicting, changing, or confusing information or instructions from the state . . . or other similar difficulties (e.g., education, literacy, and/or language barriers) in understanding what information the state needed from the individual [.]" UIPL 20-21 Change 1, at 10.

The fact that claimant was initially paid PUA benefits and later determined to be ineligible does not, in and of itself, show that claimant's ineligibility stemmed from either his misrepresentation of a material

fact or a failure to provide information necessary for the Department to determine that claimant was eligible for benefits. The record does not show that claimant failed to provide information that the Department requested, or that claimant provided incorrect information. Instead, it merely shows that the Department, having reviewed the pertinent evidence, determined that claimant did not meet the statutory requirements to be eligible for PUA benefits. Under such circumstances, claimant is not at fault for the Department's initial decision to pay him benefits or its later legal conclusion that he was ineligible for those benefits.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-218595 is affirmed.
