

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0328

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department’s rules and was not eligible for benefits from April 24 through 30, 2022 (week 17-22) and until the reason for denial had ended (decision # 142543). On June 7, 2022, decision # 142543 became final without claimant having filed a request for hearing. On August 17, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant’s request, and on August 30, 2022 issued Order No. 22-UI-201658, dismissing the request as late, subject to claimant’s right to renew the request by responding to an appellant questionnaire by September 13, 2022. On September 14, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-201658 with the Employment Appeals Board (EAB). On February 13, 2023, ALJ Kangas mailed a letter to claimant stating that because claimant’s response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 22-UI-201658 remained in effect. This matter comes before EAB based upon claimant’s September 14, 2022 application for review of Order No. 22-UI-201658.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) On May 18, 2022, the Department mailed decision # 142543 to claimant’s address of record. The decision stated, “You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than June 7, 2022.” Exhibit 1 at 2.

(2) Claimant filed a late request for hearing on August 17, 2022. Exhibit 2 at 2.

CONCLUSIONS AND REASONS: Claimant’s late request for hearing is dismissed.

ORS 657.269 provides that the Department’s decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on decision # 142543 was June 7, 2022. Claimant filed a late request for hearing on August 17, 2022. In claimant’s response to the appellant questionnaire, where asked to provide the date claimant filed their appeal, claimant wrote that they believed they “called in” on June 10, 2022 and June 22, 2022. EAB Exhibit 1 at 1. As both of these dates were after the June 7, 2022 filing deadline, claimant has not alleged that they attempted to timely file a request for hearing. Accordingly, the request for hearing was late.

In their response to the appellant questionnaire, claimant did not allege that there were any delays in their receipt of decision # 142543, stating they received it May 18, 2022. EAB Exhibit 1 at 1. Claimant’s explanation for filing their request for hearing late was, essentially, that their focus at that time was on verifying their identity and proving to the Department that they had done so, which was the information requested by the Department that led to the issuance of decision # 142543. EAB Exhibit 1 at 2.

While claimant was understandably frustrated with the difficulties they experienced in the identity verification process, they have not shown that those difficulties prevented them from filing a timely request for hearing on decision # 142543. Claimant’s failure to file a request for hearing until after June 7, 2022 was more likely the result of a mistake on claimant’s part. However, it was not an “excusable mistake” within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Claimant therefore failed to demonstrate good cause to extend the filing deadline beyond June 7, 2022, and their late request for hearing is dismissed.

DECISION: Order No. 22-UI-201658 is affirmed.
