

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0344**

*Affirmed*

*Ineligible Weeks 26-20 through 28-20, 32-20 through 41-20, and 43-20 through 17-21*

**PROCEDURAL HISTORY:** On June 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from June 21 through July 11, 2020 (decision # 142154). Also on June 3, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from October 18, 2020 through May 1, 2021 (decision # 144112). Also on June 3, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from August 2 through October 10, 2020 (decision # 143252). Claimant filed timely requests for hearing on decisions # 142154, 144112, and 143252. On February 23, 2023, ALJ Logan conducted a consolidated hearing, and on March 2, 2023 issued Orders No. 23-UI-217763, 23-UI-217764, and 23-UI-217766 affirming decisions # 142154, 144112, and 143252. On March 22, 2023, claimant filed applications for review of Orders No. 23-UI-217763, 23-UI-217764, and 23-UI-217766 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-217763, 23-UI-217764, and 23-UI-217766. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2023-EAB-0342, 2023-EAB-0343, and 2023-EAB-0344).

**WRITTEN ARGUMENT:** EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-217763, 23-UI-217764, and 23-UI-217766 are affirmed.
