

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0354**

*Affirmed*  
*Late Requests to Reopen Dismissed*

**PROCEDURAL HISTORY:** On July 29, 2021, the Oregon Employment Department (the Department) served notice of seven administrative decisions, concluding respectively that claimant filed late claims for unemployment insurance benefits for the weeks of January 10, 2021 through January 16, 2021 (week 02-21), January 24, 2021 through January 30, 2021 (week 04-21), February 28, 2021 through March 6, 2021 (week 09-21), March 21, 2021 through March 27, 2021 (week 12-21), May 9, 2021 through May 15, 2021 (week 19-21), June 6, 2021 through June 12, 2021 (week 23-21), and July 4, 2021 through July 10, 2021 (week 27-21) and therefore was ineligible to receive benefits for each of those weeks (decisions # 145045, 142823, 145428, 145835, 150339, 150641, and 150921). Claimant filed timely requests for hearing on all seven of the administrative decisions.

On August 3, 2022, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing on decisions # 145045, 142823, 145428, 145835, 150339, 150641, and 150921, scheduled for August 19, 2022. On August 19, 2022, claimant failed to appear for the hearing, and ALJ Mott issued Orders No. 22-UI-200894, 22-UI-200890, 22-UI-200892, 22-UI-200883, 22-UI-200886, 22-UI-200888, and 22-UI-200885, dismissing claimant's requests for hearing on decisions # 145045, 142823, 145428, 145835, 150339, 150641, and 150921, respectively, due to claimant's failure to appear. On September 8, 2022, Orders No. 22-UI-200894, 22-UI-200890, 22-UI-200892, 22-UI-200883, 22-UI-200886, 22-UI-200888, and 22-UI-200885 became final without claimant having filed requests to reopen the hearing. On September 9, 2022, claimant filed a late request to reopen the August 19, 2022 hearing.

On February 10, 2023, OAH served notice of a consolidated hearing scheduled for March 6, 2023 to determine whether claimant had good cause to file the late request to reopen the August 3, 2022 hearing, if so, whether claimant had good cause for failing to appear at the August 19, 2022 hearing, and, if so, the merits of decisions # 145045, 142823, 145428, 145835, 150339, 150641, and 150921. On March 6, 2023, claimant failed to appear at the hearing, and ALJ Sachet-Rung issued Orders No. 23-UI-217991, 23-UI-217996, 23-UI-217997, 23-UI-217992, 23-UI-217994, 23-UI-217995, and 23-UI-217993, dismissing claimant's late requests to reopen the August 19, 2022 hearing and leaving Orders No. 22-UI-200894, 22-UI-200890, 22-UI-200892, 22-UI-200883, 22-UI-200886, 22-UI-200888, and 22-UI-200885 undisturbed. On March 22, 2023, claimant filed applications for review of Orders No. 23-UI-

217991, 23-UI-217996, 23-UI-217997, 23-UI-217992, 23-UI-217994, 23-UI-217995, and 23-UI-217993 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-217991, 23-UI-217996, 23-UI-217997, 23-UI-217992, 23-UI-217994, 23-UI-217995, and 23-UI-217993. For case-tracking purposes, this decision is being issued in septuplicate (EAB Decisions 2023-EAB-0350, 2023-EAB-0352, 2023-EAB-0351, 2023-EAB-0356, 2023-EAB-0354, 2023-EAB-0353, and 2023-EAB-0355).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-217991, 23-UI-217996, 23-UI-217997, 23-UI-217992, 23-UI-217994, 23-UI-217995, and 23-UI-217993 are affirmed.
