EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0358

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 22, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation (decision # 121202). The employer filed a timely request for hearing. On June 16, 2022, ALJ Griffin conducted a hearing, and on June 17, 2022 issued Order No. 22-UI-196423, affirming decision # 121202. On June 27, 2022, the employer filed an application for review with the Employment Appeals Board (EAB). On September 23, 2022, EAB issued EAB Decision 2022-EAB-0725, reversing Order No. 22-UI-196423 and remanding the matter for further development of the record. On October 11, 2022, ALJ Griffin conducted a hearing, and on October 17, 2022 issued Amended Order No. 22-UI-205257¹ reversing decision # 121202 by concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving benefits effective January 23, 2022. On November 7, 2022, Amended Order 22-UI-205257 became final without claimant having filed an application for review. On March 23, 2023, claimant filed a late application for review.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement accompanying his application for review and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Amended Order No. 22-UI-205257, mailed to claimant on October 17, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Amended Order No. 22-UI-205257 at 5. Amended Order No. 22-UI-205257 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 7, 2022 to be timely."

¹ Order No. 22-UI-205257 amended Order No. 22-UI-205125, which was issued on October 13, 2022. The amended order changed the effective date of the disqualification from January 22, 2022 to January 23, 2022.

(2) On March 23, 2023, claimant filed an application for review of Amended Order 22-UI-205257.

CONCLUSIONS AND REASONS: Claimant's late application for review of Amended Order No. 22-UI-205257 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Amended Order No. 22-UI-205257 was due November 7, 2022. Because claimant did not file their application for review until March 23, 2023, the application for review was late. Claimant provided a written statement with the application of review that indicated that they attempted to file an application for review by email on January 24, 2023, but mistakenly sent this email to an incorrect email address. EAB Exhibit 1 at 1. However, even if claimant had sent an application for review to the correct email address on January 24, 2023, such an application for review still would have been filed more than two months after Amended Order No 22-UI-205257 became final. Claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed March 23, 2023 is dismissed. Amended Order No. 22-UI-205257 remains undisturbed.
