

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0377**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On April 25, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and was disqualified from benefits effective June 13, 2021 (decision # 145819). On May 16, 2022, decision # 145819 became final without claimant having filed a request for hearing. On July 25, 2022, the Department served notice of an administrative decision based in part on decision # 145819 concluding that claimant received \$4,984 in regular unemployment insurance benefits and \$2,400 in Federal Pandemic Unemployment Compensation (FPUC) to which claimant was not entitled and must repay (decision # 111215). On August 15, 2022, decision # 111215 became final without claimant having filed a request for hearing.

On October 6, 2022, claimant filed late requests for hearing on decisions # 145819 and # 111215. ALJ Kangas considered claimant's requests, and on January 30, 2023 issued Orders No. 23-UI-214163 and 23-UI-214164, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by February 13, 2023. On February 13, 2023, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on February 27, 2023 issued Orders No. 23-UI-217277 and 23-UI-217276, re-dismissing claimant's requests for hearing as late without good cause. On March 6, 2023, claimant filed timely applications for review of Orders No. 23-UI-217277 and 23-UI-217276 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-217277 and 23-UI-217276. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0377 and 2023-EAB-0378).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-217277 and 23-UI-217276 are affirmed.
