EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0381

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 9, 2021, the Oregon Employment Department (the Department) served a Notice of Determination of Pandemic Unemployment Assistance (PUA) concluding claimant was not entitled to PUA benefits effective February 9, 2020. On March 1, 2021, the PUA determination became final without claimant having filed a timely request for hearing. On July 8, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 11, 2022, issued Order No. 22-UI-204859, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 25, 2022. On October 31, 2022, Order No. 22-UI-204859 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On March 31, 2023, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, which included a partial response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-204859, mailed to the claimant on October 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-204859 at 2. Order No. 22-UI-204859 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 31, 2022."

CONCLUSIONS AND REASONS: The claimant's late application for review of Order No. 22-UI-204859 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-204859 was due by October 31, 2022. Because the claimant did not file their application for review until March 31, 2023, the application for review was late. Claimant provided an incomplete response to the appellant questionnaire with their application for review, but it did not describe circumstances that prevented them from filing the application for review on time. EAB Exhibit 1 at 2. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed March 31, 2023 is dismissed. Order No. 22-UI-204859 remains undisturbed.
