

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0393**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On June 24, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from May 29, 2022 through June 4, 2022 (week 22-22) and was not eligible for benefits for that week (decision # 100516). On July 14, 2022, decision # 100516 became final without claimant having filed a request for hearing. On August 2, 2022, the Department served notice of an administrative decision based in part on decision # 100516, concluding that claimant received \$733 in benefits to which he was not entitled and must repay (decision # 172425). On August 8, 2022, claimant filed a late request for hearing on decision # 100516 and a timely request for hearing on # 172425. On March 17, 2023, ALJ Lewis conducted a consolidated hearing and issued Order No. 23-UI-219482, dismissing claimant's request for hearing as late without good cause and leaving decision # 100516 undisturbed. On March 24, 2023, ALJ Lewis issued Order No. 23-UI-220079, affirming decision # 172425. On April 3, 2023, claimant filed applications for review of Orders No. 23-UI-219482 and 23-UI-220079 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-219482 and 23-UI-220079. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0393 and 2023-EAB-0394).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-219482 and 23-UI-220079 are affirmed.
