# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0395

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On December 9, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving benefits effective October 23, 2022 (decision # 121230). Claimant filed a timely request for hearing. On January 24, 2023, ALJ Sachet-Rung conducted a hearing, and on February 23, 2023 issued Order No. 23-UI-216948, modifying decision # 121230 by concluding claimant was disqualified from receiving benefits effective October 30, 2022. On March 15, 2023, Order No. 23-UI-216948 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 3, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, which has been marked as EAB Exhibit 1, and claimant's written argument, which has been marked as EAB Exhibit 2, and copies provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-216948, mailed to the claimant on February 23, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-216948 at 3. Order No. 23-UI-216948 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 15, 2023 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-216948 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-216948 was due by March 15, 2023. Because the claimant did not file his application for review until April 3, 2023, the application for review was late. Claimant explains in his application for review that he filed his application for review late because he was moving residences when he received the order under review, learned that documentation he thought was available for review was not taken into consideration at the hearing, and that "all of my documents were spread amongst a lot of different packing boxes." EAB Exhibit 1 at 1. Claimant's application for review further provides that claimant found the documentation on April 3, 2023 and filed his application for review on that day. EAB Exhibit 1 at 1. Claimant submitted a copy of his "Corrective Action Plan" from the employer with his late application for review, which was treated as a written argument. EAB Exhibit 2. While claimant may have regretted not providing a copy of his "Corrective Action Plan" as an exhibit for his hearing, claimant's decision to wait to file his application for review until he could find the documentation was not a factor or circumstance beyond claimant's reasonable control that prevented him from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed April 3, 2023 is dismissed. Order No. 23-UI-216948 remains undisturbed.
