

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0402

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 144142). On July 12, 2021, the Department served notice of an administrative decision replacing decision # 144142 and concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective October 25, 2020 (decision # 110918). On August 2, 2021 decision # 110918 became final without claimant having filed a request for hearing.

On August 7, 2021, claimant filed a late request for hearing on decision # 110918.¹ ALJ Kangas considered claimant's request, and on August 18, 2021 issued Order No. 21-UI-172788, the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 1, 2021.² On August 30, 2021, claimant filed a timely response to the appellant questionnaire. On December 1, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-172788 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 110918. On March 15, 2023, ALJ Fraser conducted the hearing, and on March 16, 2023 issued Order No. 23-UI-219306, dismissing claimant's request for hearing as late without good cause, leaving decision # 110918 undisturbed.³ On April 4, 2023, claimant filed a timely application for review of Order No. 23-UI-219306 with the Employment Appeals Board (EAB).

¹ The Department mistakenly treated claimant's request for hearing as a late request for hearing on decision # 144142 instead of decision # 110918.

² Order No. 21-UI-172788 mistakenly refers to the request at issue as a request for hearing on decision 144142 by the employer, instead of claimant's request for hearing on decision # 110918.

³ Order No. 23-UI-219306 dismissed the August 7, 2021 request for hearing on decision # 110918 as late without good cause, but mistakenly states, "The administrative decision mailed May 24, 2021 remains undisturbed." The underlying decision under appeal was decision # 110918, mailed on July 12, 2021, which replaced decision # 144142, mailed on May 25, 2021.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-219306 is affirmed.
