EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0424

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 17, 2020, the Oregon Employment Department (the Department) served notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA effective February 2, 2020. On January 6, 2021, the December 17, 2020 PUA determination became final without claimant having filed a request for hearing. On January 18, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 18, 2022 issued Order No. 22-UI-191497, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 2, 2022. On April 30, 2022, claimant filed a timely response to the appellant questionnaire. The Office of Administrative Hearings (OAH) considered claimant's response, and on July 8, 2022 mailed claimant a letter cancelling and vacating Order No. 22-UI-191497, and stating that a hearing would be scheduled on whether claimant's late request for hearing should be allowed and, if so, the merits of on December 17, 2020 PUA determination. On February 21, 2023, ALJ Frank conducted the hearing, and on March 1, 2023 issued Order No. 23-UI-217570, dismissing claimant's late request for hearing as late without good cause, leaving the December 17, 2020 PUA determination undisturbed. On March 1, 2023, Order No. 23-UI-217570 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 12, 2023, claimant filed a late application for review with EAB.

FINDING OF FACT: Order No. Order No. 23-UI-217570, mailed to claimant on March 1, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-217570 at 4. Order No. 23-UI-217570 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 21, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-217570 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-217570 was due March 21, 2023. Because claimant did not file their application for review until April 12, 2023, the application for review was late. Claimant's application for review did not include a written statement describing circumstances that prevented them from filing the application for review by the March 21, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed April 12, 2023 is dismissed. Order No. 23-UI-217570 remains undisturbed.
