EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0429

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On May 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective January 3, 2021 (decision # 91359). On June 8, 2021, decision # 91359 became final without claimant having filed a request for hearing. On June 9, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 15, 2021 issued Order No. 21-UI-170433, dismissing the request as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by July 29, 2021. On July 21, 2021, claimant filed a timely response to the appellant questionnaire.

On April 27, 2022, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for August 1, 2022 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 91359. On August 1, 2022, claimant failed to appear at the hearing and, on August 2 2022, ALJ Smith issued Order No. 22-UI-199548, dismissing claimant's request for hearing for failure to appear, leaving decision # 91359 undisturbed. On August 22, 2022, Order No. 22-UI-199548 became final without claimant having filed a request to reopen the August 1, 2022 hearing. On January 24, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on April 10, 2023 issued Order No. 23-UI-221629, dismissing the request as late without good cause, leaving Order No. 22-UI-199548 undisturbed. On April 15, 2023, claimant filed a timely application for review of Order No. 23-UI-221629 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-221629 is affirmed.
