# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0445

# Affirmed Late Request for Hearing Dismissed

**PROCEDURAL HISTORY:** On April 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$1,967 in regular unemployment insurance and \$1,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which they were not entitled and must repay (decision # 83957). On May 9, 2022, decision # 83957 became final without claimant having filed a request for hearing. On September 4, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 22, 2022 issued Order No. 22-UI-210750, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 5, 2023. On January 10, 2023, claimant filed an application for review with the Employment Appeals Board (EAB). On April 13, 2023, ALJ Kangas mailed claimant a letter stating that because they did not file a timely response to the appellant questionnaire, a new order would not be issued, and Order No. 22-UI-210750 remained undisturbed. This matter comes before EAB based on claimant's January 10, 2023 application for review of Order No. 22-UI-210750.

**FINDINGS OF FACT:** (1) On April 18, 2022, the Department mailed decision # 83957 to claimant at claimant's address of record on file with the Department. Decision # 83957 stated, "If you disagree with the amount of the overpayment, you have the right to appeal this decision. Any appeal from this decision must be filed on or before May 9, 2022 to be timely." Exhibit 1 at 2.

(2) On January 10, 2023 claimant filed an application for review of Order 22-UI-210750. Claimant's application for review did not contain a response to the appellant questionnaire or an explanation as to why claimant's request for hearing on decision # 83957 was filed late.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

On April 18, 2022, the Department mailed decision # 83957 to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was May 9, 2022. Claimant did not file a request for hearing on decision # 83957 until September 4, 2022. Accordingly, claimant's request was late.

Because claimant did not respond to the appellant questionnaire or provide an explanation as to why claimant's request for hearing was late, the record does not contain sufficient information to conclude that claimant filed their request for hearing on decision # 83957 late due to factors beyond claimant's reasonable control or an excusable mistake. Accordingly, claimant has not shown good cause to extend the deadline for timely filing their request for hearing, and the late request for hearing is dismissed.

## DECISION: Order No. 22-UI-210750 is affirmed.
