EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0447

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits and disqualifying claimant for 52 weeks of future benefits (decision # 195350). On April 27, 2021, decision # 195350 became final without claimant having filed a request for hearing. On April 30, 2021 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 26, 2021, issued Order No. 21-UI-167518, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 9, 2021. On June 8, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response, and on September 8, 2021 issued Order No. 21-UI-174245 re-dismissing claimant's request for hearing as late without good cause, leaving decision # 195350 undisturbed. On September 28, 2021, Order No. 21-UI-174245 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 3, 2023, claimant filed a late application for review of Order No. 21-UI-174245.

FINDING OF FACT: Order No. 21-UI-174245, mailed to the claimant on September 8, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-174245 at 3. Order No. 21-UI-174245 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 28, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-174245 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-174245 was due by September 28, 2021. Because the claimant did not file their application for review until April 3, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the September 28, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 3, 2023 is dismissed. Order No. 21-UI-174245 remains undisturbed.
