PROCEDURAL HISTORY: On March 30, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from March 6 through 19, 2022 and was not eligible for benefits for those two weeks (decision # 71350). On April 19, 2022, decision # 71350 became final without claimant having filed a request for hearing. On July 15, 2022, the Department served notice of an administrative decision based on decision # 71350, concluding that claimant was paid \$342 in regular unemployment insurance benefits to which they were not entitled and must repay (decision # 153344). On July 25, 2022, claimant filed a late request for hearing on decision # 71350 and a timely request for hearing on decision # 153344. On April 11, 2023, ALJ Fraser conducted hearings and issued Order No. 23-UI-221758, dismissing claimant's late request for hearing on decision # 71350, leaving that decision undisturbed. On April 12, 2023, ALJ Fraser issued Order No. 23-UI-221791, affirming decision # 153344. On April 18, 2023, claimant filed applications for review of Orders No. 23-UI-221758 and 23-UI-221791 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-221758 and 23-UI-221791. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0467 and 2023-EAB-0468).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-221758 and 23-UI-221791 are affirmed.
