EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0490

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 23, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks including December 18, 2022 through December 31, 2022 (weeks 51-22 through 52-22) and was therefore disqualified from receiving unemployment insurance benefits for those weeks (decision # 83011). Claimant filed a timely request for hearing. On March 30, 2023, ALJ Blam conducted a hearing, and on April 5, 2023 issued Order No. 23-UI-221098, affirming decision # 83011. On April 25, 2023, Order No. 23-UI-221098 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 26, 2023, claimant filed a late application for review of Order No. 23-UI-221098 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's application for review dated April 26, 2023, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-221098, mailed to claimant on April 5, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-221098 at 4. Order No. 23-UI-221098 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 25, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-221098 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by electronic means is the encoded date on the electronic document. OAR 471-041-0065(1)(e) (May 13, 2019). The encoded date on the claimant's application for review was April 26, 2023; that date is therefore the filing date.

The application for review of Order No. 23-UI-221098 was due by April 25, 2023. Because claimant did not file their application for review until April 26, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the April 25, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 26, 2023 is dismissed. Order No. 23-UI-221098 remains undisturbed.
