

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0498

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 20, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$5,604 in regular unemployment insurance and \$6,000 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled and must repay (decision # 144807). Claimant filed a timely request for hearing. On March 8, 2023, ALJ Janzen conducted a hearing, and on March 9, 2023 issued Order No. 23-UI-218444, affirming decision # 144807. On March 29, 2023, Order No. 23-UI-218444 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On April 26, 2023 claimant filed a late application for review with EAB.

FINDING OF FACT: (1) Order No. 23-UI-218444, mailed to the claimant on March 9, 2023, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 23-UI-218444 at 6. Order No. 23-UI-218444 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before March 29, 2023 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 23-UI-218444 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-218444 was due by March 29, 2023. Because the claimant did not file their application for review until April 26, 2023, the application for review was late.

Claimant's application for review did not include a written statement describing circumstances that prevented claimant from filing the application for review by the March 29, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed April 26, 2023 is dismissed. Order No. 23-UI-218444 remains undisturbed.
