EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0510

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 24, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause, disqualifying claimant from receiving benefits beginning September 11, 2022 (decision # 130222). Claimant filed a timely request for hearing. On November 22, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 6, 2022. On December 6, 2022, claimant failed to appear at the hearing, and ALJ Nyberg issued Order No. 22-UI-209015, dismissing claimant's request for hearing for failure to appear. On December 27, 2022, Order No. 22-UI-209015 became final without claimant having filed a request to reopen the hearing. On March 16, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and April 10, 2023 issued Order No. 23-UI-221558, dismissing the request as late without a showing of good cause. On May 2, 2023, claimant filed an application for review of Order No. 23-UI-221558 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the envelope in which claimant mailed their application for review and the written statement included with the application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Order No. 23-UI-221558, mailed to claimant on April 10, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-221558 at 4. Order No. 23-UI-221558 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 1, 2023 to be timely."

(2) Claimant filed their application for review by mail. The postmark date on the envelope in which claimant mailed the application for review is May 2, 2023. EAB Exhibit 1 at 1.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 23-UI-221558 was late without a showing of good cause, and therefore is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-221558 was due May 1, 2023. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review is May 2, 2023, which therefore is the filing date. EAB Exhibit 1 at 1. Because claimant did not file their application for review until May 2, 2023, the application for review was late. Claimant provided a written statement with their application for review. However, claimant's written statement did not describe circumstances that prevented claimant from filing the application for review by the May 1, 2023 deadline. EAB Exhibit 1 at 2. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 2, 2023 is dismissed. Order No. 23-UI-221558 remains undisturbed.
