**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0511**

*Application for Review Dismissed*

**PROCEDURAL HISTORY:** On December 22, 2021, the Oregon Employment Department (the Department) served notice of a Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective February 2, 2020. Claimant filed a timely request for hearing. On April 7, 2023, ALJ Lucas conducted a hearing, and on April 12, 2023 issued Order No. 23-UI-221821, reversing the December 22, 2021 PUA determination by concluding that claimant was entitled to PUA benefits from February 2, 2020 through September 4, 2021. On May 2, 2023, the Department filed an application for review with the Employment Appeals Board (EAB).

**FINDING OF FACT:** On May 10, 2023, the Department sent an email to EAB asking to withdraw their application for review of Order No. 23-UI-221821.

**CONCLUSIONS AND REASONS:** The Department's application for review is dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On May 10, 2023, EAB received a written request, by email, in which the Department withdrew their application for review of Order No. 23-UI-221821. EAB had not yet issued a decision. Under OAR 471-041-0098, the Department's request to withdraw the application for review is allowed.

**DECISION:** The application for review filed May 2, 2023 is dismissed. Order No. 23-UI-221821 remains undisturbed.
