Late Request for Hearing Allowed
No Claim Redetermination

PROCEDURAL HISTORY: On May 19, 2020, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report (WPBR) concluding that claimant did not have sufficient hours or earnings in his base year to qualify for a monetarily valid claim. On May 29, 2020, the May 19, 2020 WPBR became final without claimant having filed a request for hearing. On October 5, 2021, claimant filed a late request for hearing on the May 19, 2020 WPBR. ALJ Kangas considered claimant's request, and on December 14, 2021 issued Order No. 21-UI-181891, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 28, 2021. On December 23, 2021, claimant filed a timely response to the appellant questionnaire. On March 10, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-181891 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the May 19, 2020 WPBR. On April 13, 2023, ALJ Lucas conducted a hearing, and on April 17, 2023 issued Order No. 23-UI-222282, concluding that claimant had good cause to file the late request for hearing on the May 19, 2020 WPBR and affirming that decision on the merits. On May 7, 2023, claimant filed an application for review of Order No. 23-UI-222282 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-222282 is affirmed.
