

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0525

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 26, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective November 13, 2022 (decision # 123532). Claimant filed a timely request for hearing. On March 24, 2023, ALJ Zeitner conducted a hearing, and on April 25, 2023 issued Order No. 23-UI-223099, affirming decision # 123532. On May 9, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: This matter is set aside as unsupported by a complete record, and remanded to OAH for such other and further proceedings as may be necessary to complete the record.

ORS 657.275 provides that EAB shall review the record of the case and promptly affirm, modify, or set aside the order of the ALJ if the Director of the Department or any interested party files a timely application for review.

On May 9, 2023, EAB notified OAH that an application for review had been filed and EAB had opened a case in this matter. On May 12, 2023, EAB notified OAH that marked Exhibits 1 and 5 were not in the record and requested that they be added to the record. As of May 22, 2023, 14 days after claimant filed their application for review, marked Exhibits 1 and 5 had not been added to the record. The record therefore is not yet complete, and it appears that further proceedings are or may be necessary before the record can be provided. Order No. 23-UI-223099 must therefore be reversed as unsupported by a complete record, and the case remanded for such other and further proceedings as may be necessary.

DECISION: Order No. 23-UI-223099 is set aside, and this matter remanded for further proceedings consistent with this order.
