

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0543

Affirmed
Request to Reopen Allowed
Overpayment, No Penalties

PROCEDURAL HISTORY: On June 24, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$7,456.00 in regular unemployment insurance (regular UI) benefits, \$4,200.00 in Federal Pandemic Unemployment Compensation (FPUC) benefits, and \$600.00 in Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department, a \$3,496.80 monetary penalty, and a 52-week penalty disqualification from future benefits. Claimant filed a timely request for hearing. On January 31, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 6, 2023. On February 6, 2023, ALJ Mott convened a hearing at which claimant filed to appear, and on February 9, 2023 issued Order No. 23-UI-215471, dismissing claimant's request for hearing due to his failure to appear.

On February 14, 2023, claimant filed a timely request to reopen the February 6, 2023 hearing. On March 29, 2023 and continuing on April 20, 2023, ALJ Mott conducted a hearing, and on April 25, 2023 issued Order No. 23-UI-223055, allowing claimant's request to reopen the February 6, 2023 hearing and modifying the June 24, 2022 administrative decision by concluding that claimant was overpaid \$7,336.00 in regular UI benefits, \$4,200.00 in FPUC benefits, and \$600.00 in LWA benefits that claimant was liable to repay to the Department, but that claimant did not willfully make a misrepresentation and fail to report a material fact to obtain benefits, and therefore did not assess a monetary penalty or penalty disqualification weeks. On May 12, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-223055 is affirmed.
