

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0544

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY: On January 13, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective December 18, 2022 (decision # 125906). Claimant filed a timely request for hearing. On April 27, 2023, ALJ Buckley conducted a hearing, and on May 5, 2023 issued Order No. 23-UI-224077, reversing decision # 125906 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving unemployment insurance benefits based on the work separation. On May 9, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 23-UI-224077 presents no justiciable controversy and is dismissed.

On May 9, 2023, claimant filed with EAB an application for review of Order No. 23-UI-224077, an order that concluded that claimant was not disqualified from receiving unemployment insurance benefits based on their work separation from the employer. Claimant did not assign error to any portion of that order, did not request reversal of any portion of that order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review of Order No. 23-UI-224077. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-224077 is dismissed and Order No. 23-UI-224077 remains undisturbed.

DECISION: The application for review filed May 9, 2023 is dismissed. Order No. 23-UI-224077 remains undisturbed.
