| <p><b>EMPLOYMENT APPEALS BOARD DECISION</b><br/><b>2023-EAB-0549</b></p> |

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On March 24, 2022, the Oregon Employment Department (the Department) served notice of a determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective March 15, 2020. On April 13, 2022, the March 24, 2022 PUA determination became final without claimant having filed a request for hearing. On April 6, 2022, the Department served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits and was overpaid \$31,310 in benefits that she must repay, and assessing a \$4,516.50 monetary penalty. On April 26, 2022, the April 6, 2022 administrative decision became final without claimant having filed a request for hearing.

On June 16, 2022, claimant filed late requests for hearing on the March 24, 2022 PUA determination and the April 6, 2022 administrative decision. ALJ Kangas considered claimant requests for hearing, and October 11, 2022 issued Orders No. 22-UI-204845 and 22-UI-204858, dismissing the requests as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by October 25, 2022. On October 31, 2022, Orders No. 22-UI-204845 and 22-UI-204858 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 12, 2023, claimant filed a late application for review of Orders No. 22-UI-204845 and 22-UI-204858 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-204845 and 22-UI-204858. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0548 and 2023-EAB-0549).

**FINDING OF FACT:** (1) Orders No. 22-UI-204845 and 22-UI-204858, mailed to claimant on October 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Orders No. 22-UI-204845 and 22-UI-204858 at 2. Orders No. 22-UI-204845 and 22-UI-204858 also stated on their Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 31, 2022."

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Orders No. 22-UI-204845 and 22-UI-204858 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Orders No. 22-UI-204845 and 22-UI-204858 was due October 31, 2022. Because claimant did not file their application for review until May 12, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe circumstances that prevented her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

**DECISION:** The application for review filed May 12, 2023 is dismissed. Orders No. 22-UI-204845 and 22-UI-204858 remain undisturbed.
