## EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0550

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 9, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was not eligible to receive unemployment insurance benefits for the week of October 23, 2022 through October 29, 2022 (week 43-22) and until the reason for the denial had ended (decision # 90343). On November 29, 2022, decision # 90343 became final without claimant having filed a request for hearing. On December 5, 2022, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on April 4, 2023 issued Order No. 23-UI-220997, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 18, 2023. On April 24, 2023, Order No. 23-UI-220997 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On May 6, 2023, claimant filed a late response to the appellant questionnaire and an application for review of Order No. 23-UI-220997 with EAB. On May 11, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered and a new order would not be issued. This matter comes before EAB based on claimant's May 6, 2023 late application for review of Order No. 23-UI-220997.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's appellant questionnaire response, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-220997, mailed to claimant on April 4, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-220997 at 2.

Order No. 22-UI-220997 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 24, 2023."

**CONCLUSION AND REASONS:** Claimant's late application for review is dismissed.

An application for review to EAB is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-220997 was due April 24, 2023. Because claimant did not file their application for review until May 6, 2023, the application for review was late. Claimant provided a response to the appellant questionnaire with the application for review. However, claimant did not explain why the application for review was late or assert any circumstances they faced that prevented them from timely filing their application for review. Accordingly, claimant did not show good cause for the late application for review to EAB, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed May 6, 2023 is dismissed. Order No. 23-UI-220997 remains undisturbed.
