

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0556

Affirmed
Ineligible Weeks 07-23 and 09-23

PROCEDURAL HISTORY: On March 2, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible for benefits for the week of February 12 through 18, 2023 (week 07-23) and until the reason for the denial ended. Claimant filed a timely request for hearing. On May 2, 2023, ALJ Micheletti conducted a hearing, and on May 8, 2023 issued Order No. 23-UI-224266, modifying¹ the March 2, 2023 administrative decision by concluding that claimant was ineligible for benefits for week 07-23 and the week of February 26 through March 4, 2023 (week 09-23). On May 11, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-224266 is affirmed.

However, as the order under review concluded that claimant's ineligibility dates were different from the dates found on the March 2, 2023 administrative decision, the order *modified* the administrative decision.
