

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0581**

*Affirmed*  
*Ineligible Weeks 32-22 through 49-22*

**PROCEDURAL HISTORY:** On March 21, 2023, the Oregon Employment Department (the Department) served notice of three administrative decisions concluding that claimant filed a late claim for unemployment insurance benefits for the weeks from August 7 through October 1, 2022 (weeks 32-22 through 39-22), October 2 through November 26, 2022 (weeks 40-22 through 47-22), and November 27 through December 10, 2022 (weeks 48-22 and 49-22), and therefore was denied benefits for those weeks (decisions # 100744, 101257 and 101652). Claimant filed timely requests for hearing on decisions # 100744, 101257 and 101652. On May 2, 2023, ALJ Monroe conducted a hearing, and on May 5, 2022 issued Orders No. 23-UI-224111, 23-UI-224106, and 23-UI-224103, affirming decisions # 100744, 101257, and 101652. On May 22, 2023, claimant filed applications for review of Orders No. 23-UI-224111, 23-UI-224106 and 23-UI-224103 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-224111, 23-UI-224106 and 23-UI-224103. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2023-EAB-0583, 2023-EAB-0582 and 2023-EAB-0581).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-224111, 23-UI-224106, and 23-UI-224103 are affirmed.
