

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0584

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective December 13, 2020 (decision # 71039). Claimant filed a timely request for hearing. On November 29, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 7, 2022 at 1:30 p.m. On December 7, 2022, claimant failed to appear for the hearing, and on December 8, 2022 ALJ Clemons issued Order No. 22-UI-209255, dismissing claimant's request for hearing due to claimant's failure to appear and leaving decision # 71039 undisturbed. On December 28, 2022, Order No. 22-UI-209255 became final without claimant having filed a request to reopen the December 7, 2022 hearing.

On January 23, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on March 21, 2023 issued Order No. 23-UI-219651, dismissing the request as late without good cause, and leaving Order No. 22-UI-209255 undisturbed. On April 10, 2023, Order No. 22-UI-219651 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 6, 2023 claimant filed a submission with OAH that EAB treated as a late application for review of Order No. 23-UI-219651.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with their late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-219651, mailed to claimant on March 21, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-219651 at 4.

Order No. 23-UI-219651 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before April 10, 2023 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 23-UI-219651 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-219651 was due April 10, 2023. Because claimant did not file their application for review until May 6, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed May 6, 2023 is dismissed. Order No. 23-UI-219651 remains undisturbed.
