

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0588**

*Order No. 23-UI-223965 – Late Request for Hearing Allowed, Affirmed – Ineligible Week 16-21*  
*Order No. 23-UI-223994 – Affirmed – Overpayment and Penalties*

**PROCEDURAL HISTORY:** On May 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from April 18, 2021 through April 24, 2021 (week 16-21) and was not eligible for unemployment insurance benefits for that week (decision # 74540). On May 24, 2021, decision # 74540 became final without claimant having filed a request for hearing. On March 25, 2022, the Department served notice of an administrative decision, based in part on decision # 74540, concluding that claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing an overpayment of \$9,745.00 in regular unemployment insurance (regular UI) benefits and \$3,900.00 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department, a \$4,093.50 monetary penalty, and a 52-week penalty disqualification from future benefits (decision # 192939). On March 31, 2022, claimant filed a late request for hearing on decision # 74540 and a timely request for hearing on decision # 192939. On April 26, 2023, ALJ Roberts conducted a hearing on decision # 74540 and a separate hearing on decision # 192939 at which the employer American Broadcasting Company failed to appear. On May 4, 2023, ALJ Roberts issued Order No. 23-UI-223965, allowing claimant’s late request for hearing on decision # 74540 and affirming that administrative decision on the merits. Also on May 4, 2023, ALJ Roberts issued Order No. 23-UI-223994, affirming decision # 192939. On May 23, 2023, claimant filed applications for review of Orders No. 23-UI-223965 and 23-UI-223994 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-223965 and 23-UI-223994. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0589 and 2023-EAB-0588).

**WRITTEN ARGUMENT:** Claimant did not declare that he provided a copy of his argument to the parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant’s reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Orders No. 23-UI-223965 and 23-UI-223994 are affirmed.
