EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0592

Affirmed

Late Requests for Hearing on Decisions # 121345 and 110048 Allowed Ineligible Weeks 21-21 through 30-21 and 32-21 through 38-21 Overpayment and Penalties

PROCEDURAL HISTORY: On April 18, 2022, the Oregon Employment Department (the Department) served notice of two administrative decisions concluding that claimant was not available for work from August 8 through September 25, 2020¹ and May 23 through July 31, 2021 (weeks 21-21 through 30-21) and was not eligible for benefits for those periods (decisions # 121345 and 110048, respectively). On May 9, 2022, decisions # 121345 and 110048 became final without claimant having filed requests for hearing on those decisions.

On May 13, 2022, the Department served notice of an administrative decision based in part on decisions # 121345 and 110048, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits and assessing an overpayment of \$18,702.00 in regular unemployment insurance (regular UI), \$3,514.00 in Pandemic Emergency Unemployment Compensation (PEUC), \$600.00 in Lost Wages Assistance (LWA), and \$15,900.00 in Federal Pandemic Unemployment Compensation (FPUC) benefits, an \$11,434.80 monetary penalty, and a penalty disqualification for 52-weeks of future benefits. On May 28, 2022, claimant late requests for hearing on decisions # 121345 and 110048, and a timely request for hearing on the May 13, 2022 administrative decision.

On April 3 and 20, 2023, ALJ Goodrich conducted a consolidated hearing, and on May 10, 2023 issued Order No. 23-UI-224471 allowing claimant's late request for hearing on decision # 121345 and modifying that decision by concluding that claimant was unavailable for work and therefore ineligible for benefits for the weeks of August 8 through September 25, 2021 (weeks 32-21 through 38-21).² Also

¹ This time period does not correspond with numbered benefit weeks as it does not begin on a Sunday and end on a Saturday. At hearing, it was established that decision # 121345 was intended to deny benefits for the weeks of August 8, *2021* through September 25, *2021* (weeks 32-21 through 38-21). ² Although Order No. 23-UI-224471 stated that it affirmed decision # 121345, it modified that decision by changing the year of the effective dates of the disqualification from 2020 to 2021, as explained in footnote 1.

on May 10, 2023, ALJ Goodrich issued Order No. 23-UI-224473 allowing claimant's late request for hearing on decision # 110048 and affirming that decision. On May 16, 2023, ALJ Goodrich issued Order No. 23-UI-224940, affirming the May 13, 2022 administrative decision. Claimant filed timely applications for review of Orders No. 23-UI-224471, 23-UI-224473, and 23-UI-224940 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-224471, 23-UI-224473, and 23-UI-224940. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2023-EAB-0591, 2023-EAB-0590, and 2023-EAB-0592, respectively).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-224471, 23-UI-224473, and 23-UI-224940 are affirmed.
