EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0594

Late Application for Review Dismissed

PROCEDURAL HISTORY: On May 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's requests for waivers of overpayment of regular unemployment insurance (regular UI) benefits, Federal Pandemic Unemployment Compensation (FPUC) benefits, and Lost Wages Assistance (LWA) benefits that the Department had previously assessed on December 29, 2021 (decision # 141421). On June 7, 2022, decision # 141421 became final without claimant having filed a request for hearing. On January 18, 2023, claimant filed a late request for hearing. ALJ Kangas considered the request, and on February 23, 2023 issued Order No. 23-UI-216887, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 9, 2023. On March 7, 2023, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on April 10, 2023 issued Order No. 23-UI-221647, canceling Order No. 23-UI-216887, re-dismissing claimant's request for hearing as late without a showing of good cause, and leaving decision # 141421 undisturbed. On May 1, 2023, Order No. 23-UI-221647 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 24, 2023, claimant filed a late application for review of Order No. 23-UI-221647 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement accompanying her application for review and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-221647, mailed to claimant on April 10, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-221647 at 2. Order No. 23-UI-221647 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 1, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-221647 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-221647 was due May 1, 2023. Because claimant did not file their application for review until May 24, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 24, 2023 is dismissed. Order No. 23-UI-221647 remains undisturbed.
