

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0598**

*Affirmed*  
*Ineligible for PUA Weeks 08-20 through 23-20; 25-20 through 35-20;*  
*37-20 through 01-21; 09-21 through 11-21*

**PROCEDURAL HISTORY:** On May 25, 2021 and September 15, 2021, the Oregon Employment Department (the Department) served Notices of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective December 6, 2020. Claimant filed timely requests for hearing on the determinations. On May 11, 2023, ALJ Monroe conducted a consolidated hearing, and on May 18, 2023 issued Orders No. 23-UI-225384 and 23-UI-225381, modifying the May 25, 2021 and September 15, 2021 PUA Determinations by concluding that claimant was ineligible to receive PUA for the weeks of February 26, 2020 through June 6, 2020 (weeks 08-20 through 23-20), June 14, 2020 through August 29, 2020 (weeks 25-20 through 35-20), September 6, 2020 through January 9, 2021 (weeks 37-20 through 01-21), and February 28, 2021 through March 20, 2021 (weeks 09-21 through 11-21).<sup>1</sup> On May 24, 2023, claimant filed applications for review of Orders No. 23-UI-225384 and 23-UI-225381 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-225384 and 23-UI-225381. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions # 2023-EAB-0598 and 2023-EAB-0599).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-225384 and 23-UI-225381 are affirmed.
