EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0605

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$9,430 in Pandemic Unemployment Assistance (PUA) benefits and \$17,100 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay to the Department, as well as a \$7,959 monetary penalty. Claimant filed a timely request for hearing. On April 24, 2023, ALJ Nyberg conducted a hearing, and on May 5, 2023 issued Order No. 23-UI-224136, modifying the March 15 administrative decision by concluding that claimant did not willfully make a misrepresentation in order to obtain unemployment benefits and therefore was not liable for a monetary penalty, but that the Department had overpaid claimant \$9,430 in PUA benefits and \$17,100 in FPUC benefits that claimant was required to repay to the Department. On May 25, 2023, Order No. 23-UI-224136 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 26, 2023, claimant filed a late application for review of Order No. 23-UI-224136 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-224136, mailed to claimant on May 5, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-224136 at 8. Order No. 23-UI-224136 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 25, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-224136 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-224136 was due by May 25, 2023. Because claimant did not file their application for review until May 26, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the May 25, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed May 26, 2023 is dismissed. Order No. 23-UI-224136 remains undisturbed.
