

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0613**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On November 6, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective March 8, 2020 (decision # 151258). On November 30, 2020, decision # 151258 became final without claimant having filed a request for hearing. On December 22, 2021, claimant filed a late request for hearing. On December 22, 2022, ALJ Adamson conducted a hearing to determine if claimant had good cause to file her late request for hearing and, if so, the merits of decision # 151258. On December 30, 2022, ALJ Adamson issued Order No. 22-UI-211334, modifying decision # 151258 by concluding that claimant was discharged, but not for misconduct, within 15 days of voluntarily quitting work without good cause, and was therefore disqualified from receiving benefits effective March 22, 2020. On January 19, 2023, Order No. 22-UI-211334 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On March 20, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the information claimant included with her application for review to explain why it was late, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) Order No. 22-UI-211334, mailed to claimant on December 30, 2022, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-211334 at 6. Order No. 22-UI-211334 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 19, 2023 to be timely.” Claimant did not receive this copy of Order No. 22-UI-211334.

(2) At some time between January 20, 2023 and March 3, 2023, claimant called the Office of Administrative Hearings (OAH) because she had not received a written decision following the December 22, 2022 hearing. Claimant also submitted a written request for a copy of the decision to OAH during this time.

(3) On March 3, 2023, OAH mailed a copy of Order No. 22-UI-211334 to claimant.

(4) On March 6, 2023, claimant received the copy of Order No. 22-UI-211334.

(5) On March 20, 2023, claimant filed her late application for review with EAB.

**CONCLUSION AND REASONS:** Claimant’s late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-211334 was due by January 19, 2023. Because claimant did not file her application for review until March 20, 2023, the application for review was late. EAB Exhibit 1 at 5. Claimant included a written statement and supporting evidence with her application for review explaining why it was late. Claimant did not receive the copy of the order under review that was mailed to her on December 30, 2022. EAB Exhibit 1 at 2-3. Claimant stated that she received her only copy of Order No. 22-UI-211334 on March 6, 2023. EAB Exhibit 1 at 2. Claimant’s failure to receive the copy of Order No. 22-UI-211334 mailed December 30, 2022 was a factor beyond claimant’s reasonable control that prevented timely filing of her application for review.

However, that factor ceased on March 6, 2023, when claimant received a copy of Order No. 22-UI-211334. Claimant’s statement and supporting evidence did not show that there were additional factors or circumstances that delayed filing of her application for review beyond March 6, 2023. Accordingly, claimant has shown good cause to extend the period for timely filing a seven-day “reasonable time” beyond March 6, 2023, to March 13, 2023. Because claimant’s application for review was filed March 20, 2023, it was not filed within a “reasonable time” after the circumstances that prevented the timely filing ceased to exist. Therefore, claimant’s late application for review is dismissed.

**DECISION:** The application for review filed March 20, 2023 is dismissed. Order No. 22-UI-211334 remains undisturbed.
