EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0617

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 28, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not eligible for Extended Benefits from October 25 through December 12, 2020 (weeks 44-20 through 50-20) (decision # 111649). On June 17, 2021, decision # 111649 became final without claimant having filed a request for hearing. On November 15, 2022, claimant filed a late request for hearing. On April 6, 2023, ALJ Lucas conducted a hearing, and on April 11, 2023 issued Order No. 23-UI-221687, dismissing claimant's late request for hearing and leaving that decision # 111649 undisturbed. On May 1, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

In her written argument, claimant asserted that the Department's witness testified at hearing that "the hearing was in regards to Decision # 111858 which was misleading and incorrect," and that this led claimant to testify about that administrative decision rather than decision # 111649. Claimant's Written Argument at 2. The record does not show that the Department's witness made such a statement at hearing. Furthermore, the record shows that, prior to the beginning of testimony, the ALJ explained to the parties that the matters at issue in the hearing were whether claimant had good cause to file the late request for hearing and, if so, whether claimant was eligible for extended benefits. Audio Record at 7:30. After claimant inquired about whether other issues would be heard in that hearing, the ALJ further explained that those were the *only* issues before him in that hearing. Audio Record at 8:44.

For the sake of clarity, EAB reviewed Department records and found that claimant's November 15, 2022 request for hearing was construed as late requests for hearing on *three* separate administrative decisions:

• The first administrative decision is the decision at issue here: decision # 111649, issued on May 28, 2021, regarding claimant's eligibility for Extended Benefits.

- The second, decision # 111858, also issued on May 28, 2021, is regarding claimant's eligibility for Pandemic Emergency Unemployment Compensation (PEUC) benefits. On May 15, 2023, ALJ Lucas conducted a hearing on that case, and on May 19, 2023 issued an order allowing claimant's late request for hearing on decision # 111858, and affirming that decision on the merits by concluding that claimant was not eligible for PEUC benefits.
- The third, decision # 161517, issued on June 24, 2022 and based in part on decision # 11649, assessed an overpayment of \$2,611 in Extended Benefits that claimant was required to repay the Department via deductions from future benefits. A notice of hearing regarding claimant's request for hearing on decision # 161517 was mailed to claimant on May 31, 2023. That hearing, set for June 22, 2023, will address whether claimant had good cause to file the late request for hearing on decision # 161517 and, if so, whether claimant is liable for an overpayment of Extended Benefits.

Claimant also should note that the Department may defer recovery or completely waive the overpaid amount if certain standards are met. To make a request for Waiver of Overpayment Recovery, call 503-947-1995 or email OED_Overpayment_unit@employ.oregon.gov. You must submit waiver applications that correspond to the program for which you were overpaid benefits. If you were overpaid benefits under both state and federal benefits programs, you will need to file two separate waiver applications. To access a State UI Overpayment Waiver application go online to https://unemployment.oregon.gov/waivers and click the link for "State UI Overpayment Waiver". To access a Federal Program Overpayment Waiver application go online to https://unemployment.oregon.gov/waivers and click the link for "Federal Program Overpayment Waiver".

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-221687 is affirmed.
