

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0622**

*Late Application for Review Dismissed*  
*No Justiciable Controversy*

**PROCEDURAL HISTORY:** On January 6, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which she was not entitled, and assessing an overpayment of \$586 in benefits that claimant was required to repay (decision # 193307). Claimant filed a timely request for hearing. On April 27, 2023, ALJ Mott conducted a hearing, and on May 1, 2023 issued Order No. 23-UI-223579, reversing decision # 193307 by concluding that claimant did not receive benefits to which she was not entitled, and therefore was not liable to repay benefits to the Department. On May 22, 2023, Order No. 23-UI-223579 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On May 30, 2023, claimant filed a late application for review of Order No. 23-UI-223579 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-223579, mailed to claimant on May 1, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-223579 at 5. Order No. 23-UI-223579 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 22, 2023 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 23-UI-223579 is dismissed because it is late and presents no justiciable controversy.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-223579 was due by May 22, 2023. Because claimant did not file their application for review until May 30, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe circumstances preventing her from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

In addition, claimant’s May 30, 2023 application for review requested review of an order that reversed the assessment of an overpayment, leaving claimant with no remaining liability for repayment of those benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling her to further relief in this matter.<sup>1</sup> Accordingly, there is no justiciable controversy before EAB based upon claimant’s application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-223579 is dismissed for this reason as well, and Order No. 23-UI-223579 remains undisturbed.

**DECISION:** The application for review filed May 30, 2023 is dismissed. Order No. 23-UI-223579 remains undisturbed.

<sup>1</sup> In her statement included with her application for review, claimant requested that EAB “make [the Department] immediately refund the \$586” she paid in February 2023. EAB Exhibit 1 at 1. Claimant should note that EAB does not have the authority to fulfill such a request. Department records indicate that claimant has since received her refund from the Department. However, if claimant has further concerns regarding this refund, claimant should contact the Department directly.
