# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0626

Applications for Review Dismissed No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 22, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the weeks including February 5, 2023 through March 4, 2023 (weeks 06-23 through 09-23) and was therefore ineligible to receive unemployment insurance benefits during those weeks (decision # 84207). On March 24, 2023, the Department served notice of an administrative decision concluding that claimant was not available for work during the weeks including January 29, 2023 through March 18, 2023 (weeks 05-23 through 11-23) and therefore was not eligible to receive benefits for those weeks and until the reason for the denial had ended (decision #80019). Claimant filed timely requests for hearing on decisions #84207 and 80019. On May 25, 2023, ALJ Janzen conducted a combined hearing on both administrative decisions. On May 26, 2023, ALJ Janzen issued Order No. 23-UI-226213, reversing decision # 80019 by concluding that claimant was available for work during the weeks including January 29, 2023 through May 20, 2023 (weeks 05-23 through 20-23) and therefore was eligible to receive benefits for those weeks. On June 7, 2023, ALJ Janzen issued Order No. 23-UI-227132, reversing decision # 84207 by concluding that claimant had actively sought work during weeks 06-23 through 09-23 and therefore was eligible to receive benefits for those weeks.<sup>1</sup> On May 31, 2023, claimant filed applications for review of Orders No. 23-UI-227132 and 23-UI-226213 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-227132 and 23-UI-226213. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0626 and 2023-EAB-0627).

Order No. 23-UI-227132 was issued to amend Order No. 23-UI-226212, claimant's application for review of Order No. 23-UI-226212 is construed to instead apply to Order No. 23-UI-227132.

That order determined that claimant had actively sought work during these weeks and stated that decision # 84207 was "set aside," but nevertheless concluded that claimant was "not eligible to receive benefits" for those weeks. Order No. 23-UI-226212 at 2–3. Order No. 23-UI-227132 was issued on June 7, 2023 in order to correct the typographical error and state that claimant *was* eligible for benefits for those weeks. **CONCLUSIONS AND REASONS:** Claimant's applications for review of Orders No. 23-UI-227132 and 23-UI-226213 present no justiciable controversy and are dismissed.

On May 31, 2023, claimant filed with EAB applications for review of orders that allowed the appellant benefits. Claimant did not assign error to any portion of those orders, did not request reversal of any portion of the orders, and alleged no facts entitling claimant to further relief in these matters. Accordingly, there is no justiciable controversy before EAB based upon claimant's applications for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the cases before EAB presents no justiciable controversy, the applications for review of Orders No. 23-UI-227132 and 23-UI-226213 are dismissed and Orders No. 23-UI-227132 and 23-UI-226213 remain undisturbed.

**DECISION:** The applications for review filed May 31, 2023 are dismissed. Orders No. 23-UI-227132 and 23-UI-226213 remain undisturbed.
