

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0632

Affirmed
No Disqualification

PROCEDURAL HISTORY: On February 17, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was suspended by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the suspension (decision # 150944). The employer filed a timely request for hearing. On April 11, 2023, ALJ Monroe conducted a hearing, and on April 19, 2023 issued Order No. 23-UI-222629, affirming decision # 150944. On May 9, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the employer's written argument when reaching this decision.

In their argument, the employer requested that "this matter be remanded for a hearing on the final separation," and further asserted that they appealed both decision # 150944 and another administrative decision (decision # 150053), issued the same day, regarding claimant's discharge from work. Employer's Written Argument at 1. The employer should note that EAB does not have jurisdiction to address decision # 150053 in this matter, as that decision was not at issue on appeal. However, the documents enclosed with the employer's argument shows that the employer originally filed two separate requests for hearing, both on March 8, 2023, regarding administrative decisions dated February 17, 2023. Employer's Written Argument at 2, 3. Those separate requests did not include decision numbers, nor did they distinguish between a separation from work and a discharge from work. Employer's Written Argument at 2, 3.

A review of Department records shows that a separate case has not been opened on decision # 150053 by the Office of Administrative Hearings (OAH). As such, EAB has forwarded the employer's written argument and enclosed documents to the Department as a potential request for hearing on decision # 150053.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-222629 is affirmed.
