

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0648

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 2, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective January 22, 2023 (decision # 131901). Claimant filed a timely request for hearing. On April 25, 2023, ALJ Sachet-Rung convened a hearing, and on April 26, 2023 issued Order No. 23-UI-223183, concluding that claimant withdrew his request for hearing on the record and dismissing his hearing request for that reason. On May 9, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019). However, even if EAB considered claimant's written explanation for moving to withdraw his request for hearing on the record, claimant's request for hearing would still be subject to dismissal.

The record shows that claimant was advised of the consequence of withdrawing his request for hearing, specifically that decision # 131901 would remain undisturbed, and that he understood that consequence when moving to withdraw. Audio Record at 22:14 to 22:42. Though claimant's written argument suggested that claimant felt he had little choice but to move to withdraw his request for hearing because he was required to return to work at his current job before the conclusion of the hearing, the record does not support the inferences that moving for withdrawal was his only choice, or that this time constraint was his only motivation for his motion. Claimant's statement that, "I'll just move on with my life here" to explain that he would not be proceeding with the hearing suggested that claimant may have moved to withdraw at that time for reasons beyond his immediate need to return to work, such as his consideration of the weight of the evidence presented to that point by the employer. Further, claimant did not inquire at the start of the hearing about the expected length of the hearing, despite knowing he had a limited break time from work in which to participate in the hearing. He did not move to continue the hearing to another time after learning that the employer would be calling at least two witnesses during the hearing,

which should have alerted claimant at the start of the hearing that it would be unlikely, if not impossible, to complete the hearing within claimant's break period. The ALJ did not preclude claimant from making a motion to continue the hearing, stating, "I need to continue and move forward unless there is a withdraw *or some other type of request made.*" Audio Record at 22:02 to 22:12. Claimant moved to withdraw at that time without seeking further clarification or making a motion to continue. Accordingly, claimant's argument, in conjunction with the record at hearing, would not have established that claimant's motion to withdraw his request for hearing was unknowing or involuntary. As such, claimant's request for hearing was properly dismissed based on his motion to withdraw it.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-223183 is affirmed.
