EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0685

Affirmed
Overpayment Waiver Granted

PROCEDURAL HISTORY: On April 20, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request for a waiver of an overpayment of federal unemployment insurance benefits that the Department had previously assessed (decision # 153636). Claimant filed a timely request for hearing. On May 25, 2023, ALJ Roberts conducted a hearing, and on June 2, 2023 issued Order No. 23-UI-226803, reversing decision # 153636 by concluding that claimant's waiver request should be granted for the remaining balance of all overpaid federal benefits. On June 16, 2023, the Department filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant and the Department both filed written arguments. Both parties' arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond their reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's and the Department's arguments to the extent they were based on the record.

Of note, the order under review determined that claimant was eligible for a waiver of her remaining overpayment balances because, in relevant part, claimant was not at fault for the overpayment of benefits. Order No. 23-UI-226803 at 4. This determination, in turn, was based in part on an examination of an administrative decision which had disqualified claimant from benefits, forming one basis for the overpayment that the Department assessed. Order No. 23-UI-226803 at 2, 4. The Department asserted in their written argument, however, that a *different* work separation, rather than the one discussed in the order under review and at hearing, was the cause of claimant's disqualification and subsequent overpayment. Department's Written Argument at 2. The Department's witness did not testify to this information at hearing. Similarly, the Department did not offer any of the underlying administrative decisions which may have created or assessed the overpayment at issue in this matter. As noted above, the Department has not shown that they were prevented from offering this information at hearing due to factors or circumstances beyond their reasonable control, and EAB therefore did not consider that

information. As such, the Department did not meet their burden at hearing to show that claimant was at fault for the overpayment at issue.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-226803 is affirmed.
